

CARLTON DENE AND PEEBLES HOUSE DEVELOPMENT

n 2021, the Council received planning consent to develop the former Carlton dene care home and Peebles house into 65 extra care homes for older people and 22 affordable homes for general needs.

The below timeline provides key dates for the programme going forward. The development will start on site March 2023 and we aim to complete the new homes by early 2025.

DEMOLISHING CARLTON DENE



e are pleased to inform you that AR Demolition has been selected as the preferred demolition contractor for the site.

AR Demolition will be demolishing the site ready for the construction build to take place.

COME AND MEET THE CONTRACTOR

Look out for posters for our 'Meet the Contractor' event coming soon. This is your opportunity to speak directly with both the project team and the contactor to find out more about the development. We look forward to seeing you there.

WHAT TO EXPECT AS WORKS GET GOING

As AR Demolition get started, neighbouring residents will notice more activity on site. The Contractor will aim to minimise distruption where possible and there will be a Site Environmental plan in place to help support this. Residents will also have direct contact with a Resident Liasion Officer who will be able to answer questions relating to the demolition throughout.

SITE ACCESS

onstruction vehicle access will be from Kilburn Park Road. This will consist of an entry and exit gate allowing vehicles to access the site in forward gear. Site Traffic Marshals will also control vehicle entry barriers to keep pedestrians safe when walking near the site.

All suppliers and waste companies will be prohibited from parking on surrounding streets.

No construction vehicles will be allowed to enter the site before 8am or after 6pm Monday to Friday, unless granted permission by Westminster City Council.



MINIMISING NOISE AND DISRUPTION

here possible, contractors will be located away from nearby residential buildings. Dust, noise, and vibration monitors will be set up in key locations around the site and will trigger an alert to pause work if agreed levels are exceeded. This will then send a notification to the Site Management who will be monitoring and recording these alerts to be reported to Environmental Health.

e are pleased to tell you that we are nearing completion of the 12 new homes being constructed behind Helmsdale, Melrose and Keith House. They will be ready this Spring. At Helmsdale House the scheme will deliver one 3- bedroom home.

three 2 -bedroom homes and two 1- bedroom homes. At Melrose and Keith House the scheme will deliver two 3-bedroom homes, two 2-bedroom homes and two 1-bedroom homes.



LOCAL HOMES FOR LOCAL PEOPLE

e have prioritised these new homes for local people in housing need through a Local Lettings Plan. Once the new homes have been completed and handed over to the Council, they will be advertised through the Choice Based Lettings Scheme.
