1 Introduction

The "Schedule of Changes to the Policies Map" (November 2019) summarises the proposed changes to Westminster's spatial designations and Policies Map for the full revision to Westminster's City Plan (document reference CORE_005). The statement accompanied the Regulation 19 Publication Draft City Plan (2019) and its associated Regulation 19 Draft Policies Map (document reference CORE_003) in its submission to the Secretary of State in November 2019. A "Submission Policies Map" (document reference CORE_004) was also submitted to account for further proposed Modifications at submission stage.

Throughout the Examination process, the council is proposing a series of Modifications to the Regulation 19 Publication Draft City Plan (2019) are made which are being logged in a "Schedule of Modifications". Some proposed Modifications affect spatial designations: this document has therefore been produced to keep a record of all the proposed changes to spatial designations and the Policies Map that the council believes need to be made alongside any proposed Modifications.

All background information about a specific spatial designation has been published in the "Schedule of Changes to the Policies Map" (November 2019), which remains the core document explaining the main changes to the Policies Map.

This document only discusses changes to spatial designations that are being proposed through the Examination process. Each time the council updates this schedule, an updated Draft Policies Map is also being published.

2 Overview of all post-submission changes to Westminster's spatial designations and Policies Map

This section presents an overview of all the proposed post-submission changes to spatial designations and the Policies Map. Modifications proposed at post-submission stage have 'PS' at the start of their reference.
