Brunel estate ventilation and fire safety work (project X253)

Thank you for your patience while we worked with our contractor, Axis Europe, to finalise the plans for the ventilation and fire safety work at the Brunel estate.

Axis Europe has now completed the detailed planning for the project and Westminster City Council has agreed their Service Providers Proposal (SPP). Work is now planned to start in October 2019 once the formal leaseholder consultation has been completed.

What does the work include?

In summary, the work includes:

- Replacing the communal extract fans, silencers, local ductwork, dampers and controls in the plantroom on the roof.
- Cleaning all ventilation ductwork (communal and in-flat).
- In-flat works to include replacement of grilles, control damper and fire dampers.
- Electrical works associated with the vents.
- Emergency lighting upgrades within the plantroom.
- Fire stopping works (communal areas only).
- Replacements of tenants' flat entrance doors with an opt-in for leaseholders at Keyham, Mickleton, Riverford and Sunderland Houses.
