## Paddington Green major works update (project T160)

We would like to thank you for your patience while we plan the major works to your home.

### Proposed scope of the work

The scope of work varies from block to block however the work covers the following key elements:

Balcony repair and replacement works Asphalt repairs to communal walkways External repairs and decoration Emergency lighting and electrical work Roof repairs or replacement depending on block Window repairs

Internal communal area repairs and redecoration

#### What is taking place in advance of the major works

As part of the design of the project, Axis Europe will be carrying out a number of surveys, starting on Monday 22 July 2019 and taking one month to complete. These will take place in the communal areas and the external of the blocks. Access to your home will <u>not</u> be required during this time. The surveys will take place Monday to Friday, between the hours of 8am and 5pm. Operatives will carry ID badges when in and around your block and will be wearing branded uniform and identification.

#### **Details of the surveys**

- 1: Aerial photographic condition surveys: are being carried out by a contractor called Upshot, starting on Monday 22 July and finishing Friday 26 July 2019. The purpose is to assess the condition of the blocks in greater detail to help plan the works.
- 2: Precautionary inspections of communal areas for asbestos: are being carried out by a contractor called Tersus, starting on Monday 22 July and finishing by Tuesday 20 August.



Residents are not at risk and there is no reason for concern. The contractor may take samples from communal areas of the building and will wear protective equipment, such as overalls and a face mask, when doing so, however this will not visibly affect decorations and will be carried out in line with the strict Health and Safety Executive (HSE) guidelines. If Axis identify any asbestos materials, we will tell you and remove or enclose any that could become a risk.

Dates for your buildings inspections are listed below:

Campbell House: 22 July Churchfield House: 23 July Crompton House: 24 and 25 July Edward House: 02 August

Cuthbert House: 26 and 29 July Devonshire House: 30 July to 01 August

Fleming Court: 5 and 6 August Gilbert Sheldon: 7 to 9 August Hall Place: 12 and 13 August Hethpool House: 14 and 15 August

Philip Court: 16 and 19 August

- 3. Fire Risk Assessment surveys (FRA) to the communal areas: are being carried out by a contractor called Carrington, starting on Monday 29 July and finishing by Tuesday 13 August. These are precautionary and will help to identify, assess and remove any potential fire hazards before works begin on the blocks.
- 4. **Drainage surveys and jet washing to the inside of the drains:** starting on **29 July and finishing by 7 August**. This will be done on a block by block basis and Axis Europe will provide a schedule closer to the time. This will help to locate and clear any existing or potential blockages.
