# Glastonbury House fire safety works – start on site (project Z251b)

We have been working with Westminster City Council (WCC) to plan how to start work using the government's COVID-19 Secure Guidance and have agreed that the work will start on **Tuesday 2 March 2021** 

This letter contains important information about the work that is planned, the timetable for the work and the health and safety measures we are taking to keep you and our team safe.

#### What does the work include?

The work includes:

- Replacing the section of external cladding on the riser for new aluminium fire rated, insulated panels.
- Fire stopping works.
- Relocating the electrical panel that operates the automatic opening vent windows.

### Timetable for work

We will be setting up our welfare facilities to the rear, lower ground level of the block from: **Monday 1 March 2021**.

Our site office will be located at The Hub, Ground Floor, Glastonbury House.

The work will take approximately 28 weeks to complete. If there are any changes to the programme, we will keep you updated.

## Replacement cladding

## **Scaffold Safety**

To start the work, we will need to erect full height scaffold and a goods hoist to the rear of Glastonbury House. The scaffold will start to go up from Tuesday 16 March 2021 and will take approximately 8 weeks to erect.

Access to your home will not be affected during the works and all equipment including ladders, will be secured at the end of each working day. We ask that you help us ensure your safety by informing visitors/carers of the planned works.

## **Access to Glastonbury House**

Pedestrian access to the rear of the building will be restricted to the area directly below the cladding whilst the scaffold is in place. This will be clearly signed.

We apologise for any inconvenience. The two rear fire doors will remain accessible.
