

## **Examination of the Westminster City Plan 2019-2040**

### **Inspectors' note**

#### **Outline of main modifications required**

- 1) Starting point is submitted City Plan i.e. Regulation 19 Publication Draft June 2019 (CORE 001) but incorporating minor modifications set out in CORE 025 V4. Main modifications are to this starting point.
- 2) Reference numbers for modifications put forward by the Council (and cross referenced below) are those in CORE 024 V4.
- 3) Unless specifically referred to below, no modifications are required for soundness. No other modifications should be added. Additional minor modifications prior to adoption are entirely a matter for the Council and should be kept completely separate from this process.
- 4) Single modification with single ref i.e. MM1 for all bullet points under each policy which may incorporate a number of specific amendments to a policy and/or associated explanatory text.
- 5) Main modifications should be shown clearly using the conventions of **bold and underlined** for new text and ~~strike through~~ for deleted text, using the text from the submitted plan as the basis. Where large sections of text are to be deleted this can be referred to as "delete para XX" or "delete para XX and replace with..". It must be absolutely clear which text is to be deleted.
- 6) The schedule of proposed main modifications should contain three columns
  - Main modification ref. e.g. MM1, MM2 etc.
  - Policy/para ref.
  - Proposed main modification
- 7) Reasons for the proposed main modifications should not be included. Reasons will be set out fully in the Inspectors' report.

*Transport for London and Strategic Road networks provided they fulfil one of the following criteria:*

- 1. The proposal forms part of a terrace or group where a variety of roof additions or alterations create an established mixed pattern and where further development of a similar form would not cause harm or would help to unify a group of buildings and townscape; or*
  - 2. The proposal would take a coordinated approach, adding roof extensions of consistent and appropriate design to each property within a terrace-of which has an existing roof line unimpaired by extensions; or*
  - 3. In other locations the proposed roof form is of appropriate design, sympathetic to the architectural character of the building and where necessary designed to minimise visibility from street level, incorporating set-backs where appropriate."*
