 some states also prohibited crime of genocide. Plan for examination  
 Ukrainian peasants was disguised in the form of the state expropriation  
 grain procurement - peasants were left with nothing, no seed.  
 1926 the last year during which the free market, as a policy of prompt  
 use still permitted, the state procured 3.3 million tonnes of grain. Ukraine  
 centralized grain procurement planned & managed by Moscow, state  
 Ukraine grain quota for 1926 was set at 4.4 million tonnes. Total for  
 the entire Soviet Union was 10.5 million tonnes. By 1930 grain procurement  
 quotas were 7.7 million tonnes for Ukraine, 20 million tonnes for Soviet Union  
 The objectives of the kulaks and forced collectivization in the kulak  
 system of farming was DESTRUCTION. Grain procurement quotas were sharply  
 higher & new families, up to 100 in place. Urban education for state  
 operation in 1930. In 1930, favorable winter conditions in Ukraine  
 harvested 23 million tonnes of grain - but winter harvest accumulation  
 by massive grain losses due to inefficiency & collection for management  
 as a result the peasants were deprived of their usual grain reserves  
 and without any traditonally used loans. Ignoring 1000's of peasants  
 thousands died 1931 grain procurement. at 7.7 million tonnes for Ukraine &  
 the other Ukraine republics 21.4 million tonnes.
