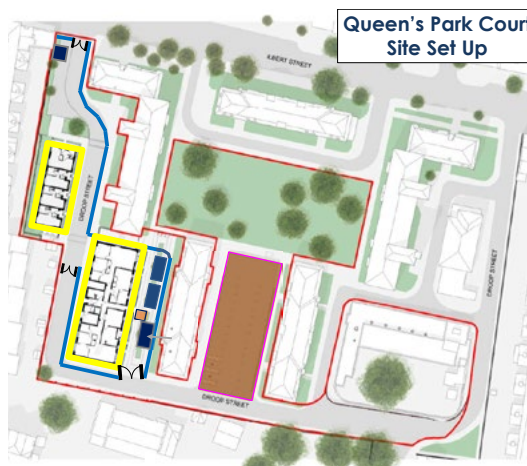


The new Queens Park development

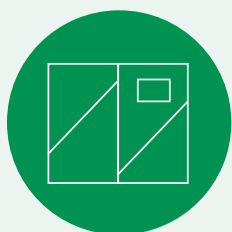

Over the coming months, we will be commencing with the following works:

Demolish sheds and remove road and carpark topping



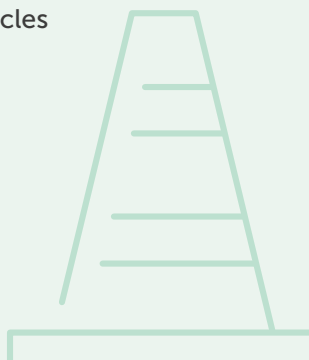
Commence cabin set up

## PARKING

Parking is still available in the area for registered permit holders in the central car park, residents can also use street parking. The area will be permit only under the housing estate traffic management order once complete.



## OPERATING HOURS

Site operating hours will be between 8am to 6pm Monday to Friday and between 8am to 1pm Saturdays.

No works will be carried out on Sundays, bank holidays or public holidays.

Should there be a one-off requirement to work after these prescribed times, Osborne will seek formal permission from the Code of Construction practice team and we will notify all residents ahead of the extended work taking place.

## NOISE AND DISRUPTION

**D**uring the construction project there will be periods of time where noisy works need to take place. Activities such as the removal of the carpark surface will generate louder than usual noise. We will of course look to mitigate disruption to local residents throughout the project.

The site is under the council's "Code of Construction Practice" to control and manage the environmental impacts of our construction activities. We maintain a Site Environmental Management Plan, which sets out how we control and minimise impacts on the neighbourhood through careful management of working hours, noise, traffic access and waste management, which is all monitored. The team has worked hard to ensure we have incorporated existing resident feedback regarding potential impacts.
