1. Headlines

This table summarises the key findings and other matters arising from the statutory audit of Westminster City Council ('the Council') and the preparation of the group and Council's financial statements for the year ended 31 March 2022 for those charged with governance.

Financial Statements

Under International Standards of Audit (UK) (ISAs) and the National Audit Office (NAO) Code of Audit Practice ('the Code'), we are required to report whether, in our opinion:

- the group and Council's financial statements give a true and fair view of the financial position of the group and Council and the group and Council's income and expenditure for the year; and
- have been properly prepared in accordance with the CIPFA/LASAAC code of practice on local authority accounting and prepared in accordance with the Local Audit and Accountability Act 2014.

We are also required to report whether other information published together with the audited financial statements (including the Annual Governance Statement (AGS), Narrative Report and Pension Fund Financial Statements), is materially inconsistent with the financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. Our audit work was largely completed on-site and remotely between June 2022 and February 2023, and then again in August to November 2023 running concurrently with the 2022/23 external audit. As of February 2023, the audit was substantially complete apart from four key areas including pensions and the collection fund appeals provision.

Due to the length of time and running the 2022/23 audit concurrently, matters were identified in the 22-23 audit which impacted and required correction within the open 21-22 accounts. The audit has now concluded, and these matters have been updated in the 21-22 financial statements and reported in this report. Versions of the earlier Audit Findings Report were presented to the October 2022 Audit and Performance Committee, and again, an updated version in February 2023. As approved by the Committee and noted in the Committee meeting on 28 November 2023, this final report will be circulated to Committee members.

Delays were encountered, due to the complexity of your financial statements, particularly the collection fund, the timing of the triannual valuation and revised IAS 19, and the pension upfront payment. This was coupled with a long-term absence within our audit team, and the need to also priortise the 22-23 audit at the same time.

Our findings are summarised on pages 6 to 24. We have identified 12 adjustments to the Main financial statements that have resulted in a £68.1m adjustment to the Council's Comprehensive Income and Expenditure Statement. Audit adjustments are detailed in Appendix C. Management have not adjusted for certain identified audit misstatements, including estimated/difference of judgement, these are set out in Appendix X. We agree with management's assessment these are not material to the 2021-22 financial statements.

We have also raised recommendations for management because of our audit work in Appendix A. Our follow up of recommendations from the prior year's audit are detailed in Appendix B.

Our work is complete, and we have issued an unmodified opinion on the financial statements.

We have concluded that the other information to be published with the financial statements, is consistent with our knowledge of Westminster City Council and the financial statements we have audited.

1. Headlines

Value for Money (VFM) arrangements

Under the National Audit Office (NAO) Code of Audit Practice ('the Code'), we are required to consider whether the Council has put in place proper arrangements to secure economy, efficiency and effectiveness in its use of resources. Auditors are now required to report in more detail on the Council's overall arrangements, as well as key recommendations on any significant weaknesses in arrangements identified during the audit.

Auditors are required to report their commentary on the Council's arrangements under the following specified criteria:

- Improving economy, efficiency and effectiveness;
- Financial sustainability; and
- Governance

Statutory duties

The Local Audit and Accountability Act 2014 ('the Act') also requires us to:

- report to you if we have applied any of the additional powers and duties ascribed to us under the Act; and
- to certify the closure of the audit.

We expect to issue our Auditor's Annual Report following the completion of the financial statements audit. This is in line with the National Audit Office's revised deadline, which requires the Auditor's Annual Report to be issued no more than three months after the date of the opinion on the financial statements.

Given the delay in signing 21-22 we have decided to produce a combined VFM report, covering 2021-22 and 2022-23. With both sets of financial statement audits concluding in November 2023, this report will be presented to the February Audit and Performance Committee. This is in accordance with the NAO's guidance and deadline.

As part of our work, we considered whether there were any risks of significant weakness in the Council's arrangements for securing economy, efficiency and effectiveness in its use of resources. Our risk assessment procedures regarding the Council's arrangements to secure value for money did not identify any risks of significant weaknesses in arrangements in 2021/22.

We did consider, however, in further detail the Council's procurement arrangements, for capital projects, particularly where procurement was £100,000 or below, following on from an internal review of the controls and governance in this area. This will be reported in the final VFM report.

We have not exercised any of our additional statutory powers or duties.

We expect to certify the completion of the audit upon the completion of our work on the Council's VFM arrangements, which will be reported in our Auditor's Annual Report in February 2024 [21-22 and 22-23 combined as referenced above].

We submitted the whole of government accounts return for 2021-22 to the NAO as required. The Council continue to be below the WGA audit threshold.

1. Headlines

Significant Matters

Increased complexity in local government financial reporting

As a large London Borough Authority, Westminster's financial statements are large and complex. Most financial statement line items, are more than our audit materiality, requiring audit procedures to be completed. In addition, as reported in the audit plan, there are several significant audit risks, which are complex to audit for example the valuation of land and buildings, investment property, and HRA properties. Over time, the Council's group structure has also changed.

The scale of regulatory and audit requirements for these accounts, has grown substantially requiring greater input and work, by the finance team and us as external auditors.

Lastly by its very nature, as a complex entity the number and value of accounting estimates and judgements, reflected in the accounts, has grown, requiring increased professional scepticism and challenge.

There continues to be a challenge in the timely delivery and conclusion of Local Government Accounts, for the reasons identified above, linked to audit and regulatory reform, which is well documented.

2. Financial Statements

Overview of the scope of our audit

This Audit Findings Report presents the observations arising from the audit that are significant to the responsibility of those charged with governance to oversee the financial reporting process, as required by International Standard on Auditing (UK) 260 and the Code of Audit Practice ('the Code'). Its contents will be discussed with management and the Audit and the Performance Committee.

As auditor we are responsible for performing the audit, in accordance with International Standards on Auditing (UK) and the Code, which is directed towards forming and expressing an opinion on the financial statements that have been prepared by management with the oversight of those charged with governance. The audit of the financial statements does not relieve management or those charged with governance of their responsibilities for the preparation of the financial statements.

Audit approach

Our audit approach was based on a thorough understanding of the Group's business and is risk based, and included:

- An evaluation of the Group's internal controls environment, including its IT systems and controls;
- An evaluation of the components of the group based on a measure of materiality considering each as a percentage of the group's gross revenue expenditure to assess the significance of the component and to determine the planned audit response. From this evaluation we determined that there were material balances within other entities within the group, on which audit procedures would need to be completed.
- Substantive testing on significant transactions and material account balances, including the procedures outlined in this report in relation to the key audit risks

Conclusion

We have issued an unmodified [unqualified] audit opinion on your 2021-22 financial statements.

The audit opinion is set out in Appendix E.

2. Financial Statements



Our approach to materiality

The concept of materiality is fundamental to the preparation of the financial statements and the audit process and applies not only to the monetary misstatements but also to disclosure requirements and adherence to acceptable accounting practice and applicable law.

We have revised the performance materiality due to the actual gross expenditure changing significantly from that at the planning stage resulting in a review of the appropriateness of the materiality figure.

We detail in the table to the right our determination of materiality for Westminster City Council and group.

2. Financial Statements - Significant risks

Significant risks are defined by ISAs (UK) as risks that, in the judgement of the auditor, require special audit consideration. In identifying risks, audit teams consider the nature of the risk, the potential magnitude of misstatement, and its likelihood. Significant risks are those risks that have a higher risk of material misstatement.

This section provides commentary on the significant audit risks communicated in the Audit Plan.

Commentary

Management override of controls Under ISA (UK) 240 there is a non-rebuttable presumed risk that the risk of management over-ride of controls is present in all entities. The Authority faces external scrutiny of its spending, and this could potentially place management under undue pressure in terms of how they report performance. We therefore identified management override of control, and in particular journals, management estimates, and transactions outside the course of business as a significant risk of material misstatement.

During 2021/22 the Council processed over 264,000 journals.

In response to the risk highlighted in the Audit Plan, we have:

- evaluated the design effectiveness of management controls over journals
- analysed the journals listing and determine the criteria for selecting high risk unusual journals
- tested unusual journals recorded during the year and after the draft accounts stage for appropriateness and corroboration
- Considered who can post and authorise journals, and considered on a risk basis, those journals approved by Senior Officers.
- gained an understanding of the accounting estimates and critical judgements applied made by management and considered their reasonableness regarding corroborative evidence
- evaluated the rationale for any changes in accounting policies, estimates or significant unusual transactions.

Our work is complete. We can confirm that the outcome of our testing, has not identified any issues or instances where journals have been inappropriately processed. Additional detail on the work performed on the most significant estimates and judgements is included on the following pages of this report.



2. Financial Statements - Significant risks

Management have engaged the services of a valuer to estimate the current value as at 31 March 2022.

We therefore identified valuation of Investment Properties, particularly revaluations and impairments, as a significant risk of material misstatement.

Our work is complete. No significant issues have been identified in our work. However increased attention across the sector in this area has led us to undertake a more detailed review in several areas which has increased the level of time spent on auditing investment property balances.

2. Financial Statements - Significant risks

Risks identified in our Audit Plan

Commentary

Valuation of pension fund net liability

The Council's pension fund net liability, as reflected in its balance sheet as the net defined benefit liability, represents a significant estimate in the financial statements. The pension fund net liability is considered a significant estimate due to the size of the numbers involved and the sensitivity of the estimate to changes in key assumptions.

The methods applied in the calculation of the IAS 19 estimates are routine and commonly applied by all actuarial firms in line with the requirements set out in the Code of practice for local government accounting (the applicable financial reporting framework). We have therefore concluded that there is not a significant risk of material misstatement in the IAS 19 estimate due to the methods and models used in their calculation.

The source data used by the actuaries to produce the IAS 19 estimates is provided by administering authorities and employers. We do not consider this to be a significant risk as this is easily verifiable.

The actuarial assumptions used are the responsibility of the entity but should be set on the advice given by the actuary. A small change in the key assumptions (discount rate, inflation rate, salary increase and life expectancy) can have a significant impact on the estimated IAS 19 liability. In particular the discount and inflation rates, where our consulting actuary has indicated that a 0.1% change in these two assumptions would have approximately 2% effect on the liability. We have therefore concluded that there is a significant risk of material misstatement in the IAS 19 estimate due to the assumptions used in their calculation. With regard to these assumptions we have therefore identified valuation of the Council's pension fund net liability as a significant risk.

In response to the risk highlighted in the Audit Plan, we have:

- updated our understanding of the processes and controls put in place by management to ensure that the pension fund net liability is not materially misstated and evaluated the design of the associated controls;
- evaluated the instructions issued by management to their management experts (the actuary) for this estimate and the scope of the actuary's work;
- assessed the competence, capabilities and objectivity of the actuary who carried out the pension fund valuation;
- assessed the accuracy and completeness of the information provided by the group to the actuary to estimate the liabilities;
- tested the consistency of the pension fund asset and liability and disclosures in the notes to the core financial statements with the actuarial reports from the actuary;
- undertook procedures to confirm the reasonableness of the actuarial assumptions made by reviewing the report of the consulting actuary (as auditor's expert) and performing any additional procedures suggested within the report; and
- Looked to obtain assurances from the auditor of the City of Westminster Pension Fund as to the controls surrounding the validity and accuracy of membership data; contributions data and benefits data sent to the actuary by the Fund and the fund assets valuation in the Fund's financial statements.

Due to timing the Council requested an updated IAS 19 report, for 2021-22, because of the timing of our audit and the latest triannual valuation being available. They considered the updated report and concluded that the impact was not material. We considered management's assessment and agreed with that assessment. The net impact on the Council's Comprehensive Income and Expenditure statement was circa £500,000 which is below trivial. On consultation with our financial reporting team, we confirmed no adjustment was required.

We identified a matter in respect of the prefunding of the pension fund deficit, requiring adjustment in the 2021-22 financial statements. See page 13 for further details.

2. Financial Statements – Key findings arising from the group audit

Work performed	Commentary
Westminster Community Homes Limited	The land and building assets of Westminster Community Homes are valued by Sanderson Weatherall alongside the Council's dwellings, using the same approach. We have considered this alongside our work on council dwellings, with no concerns noted.
	We have confirmed that the deferred grant has been treated in line with the requirements of the Code of Practice.
	As part of the 22-23 audit, we identified audit adjustments in respect of group. As a result, the disclosure of certain group balances were amended in the 21-22 accounts, to show correct comparatives in 22-23. These in effect moves balances, between lines, including between inventory, Assets Held for Sale and Assets Under Construction and PPE Land and Buildings – Dwellings [Non-HRA]. See Appendix C for adjustments agreed.
Westminster Housing Investments Limited	No issues have been noted in the treatment of the loan from the Council to Westminster Housing Investments Limited.
Other procedures	Our review and reperformance of the Council's consolidation calculations identified that both the group's gross income and gross expenditure were overstated by £31m due to an error in the consolidation (net impact £nil), which the Council has adjusted in its final financial statements.
	We identified that the Group MIRS and Group Cash Flow Statement we not initially prepared in accordance with the Code, and this has now been corrected.
	Analytical procedures at a group level have not identified any areas of concern.

2. Financial Statements – Additional Areas of focus in 2021/22 – Other Risk Areas

The significant risks identified in our Audit Plan in March remain unchanged. Here we are noting other key areas of focus in this year's audit.

Issue	Commentary
Collection Fund Income- Business Rates	Business Rate income is an area of increased audit focus in particularly for Westminster City Council, due to the £1.696 billion of income of Business Rate income within the Collection Fund and 413.7m deficit. This has led to increased audit focus on this area with us undertaking a more detailed substantive analytical procedure, review of reliefs and Income within the Collection Fund. We also placed reliance on the Council's management expert, Analyse Local, particularly in respect of the appeals provision [see below]. The Collection Fund changed, from the unaudited to audited accounts, following first review by audit and re-review by management. The key errors related to management offsetting successful Appeals and bad debt write offs against income and lead to a £139m understatement of Income. In addition, it was identified that the Appeals provision was understated by £65m which increased the overall Collection Fund Deficit. This also impacts the Collection Fund Account Reserve by the Council's increased share of this deficit - £19.5m. There were some specific challenges relating to staff turnover at the year-end in the preparation of the Collection Fund accounts, this coupled with our enhanced audit work on this area meant significantly more time was spent on this area of the accounts.
NNDR Appeals Provision	The Council's Business Rates Appeal Provision is on an absolute and relative terms one of the largest in the country at £339m in the draft accounts, of which 30% is WCC's share - £101.8m. The Appeals Provision reflects a provision against businesses that have launched the Appeals process with the VOA and the potential refunds the Council would have to pay out if they were successful. Due to the size of this provision, this has been a key focus of regulatory attention and we have expanded our procedures on this area, due to it being a key estimate in the financial statements. In undertaking our work, we have undertaken the following procedures:
	 Reviewed Management's expert Analyse Local [VOA data and appeals trends, via modelling] and LG Futures [benchmarking provision size and risk consideration which was requested to support with our enhanced audit procedures on this area].
	Challenged management on the key assumptions used in the Appeals Provision.
	 Considered the accuracy of the data used by Analyse Local which is publicly available VOA data, which the Council cannot manipulate.
	• Understood management's estimation process and the overall reasonableness of the judgements made.
	Following our audit procedures, the following adjustments were made:
	• Management updated the report to include the Checks data which increased the provision by £76m (WCC share £23.1m).
	 A subsequent adjustment relating to police stations following discussions with Analyse Local managements expert reducing the provision by £9m, WCC share £2.7m

In addition, there is an unadjusted estimation judgement difference, which we have reported of £4.4 million, of which the Council's share, reflected in the Council balance sheet. This has arisen, based on the interpretation, in Analyse Local of the respective threats. This has been reported in Appendix C of this report.

2. Financial Statements – Additional Areas of focus in 2021/22 – Other Risk Areas

Issue

Commentary

Pension Prefunding

As included in the 2019 triannual valuation, the Council paid into the Pension fund, two lump sum payments, one of £22million in 2020-21 and a further payment of £80million in 2021/22. The Council's original intention was to amortise this and treat it as in effect a prepayment and release over thirteen years.

Following review of the actuarial report, review of committee papers and legal advice sought, in 2018, when this was first considered by the Council, we determined it would be incorrect to amortise the payment.

This has been corrected in the final 2021-22 financial statements [See Appendix C for details]. The effect of this, has been a corresponding debit and credit, reducing the Council's reserves by £102million, and increasing expenditure in-year, by the same amount. This adjustment has impacted on the Comprehensive Income an Expenditure Statement, the Balance Sheet, and cash flow statement, in particular.

The accounting for this issue is complex and was made more complex due to inconsistencies in how management had accounted for this in the 2020-21 and 2021-22 financial statements.

Draft accounts

- In the 2020-21 financial statements the Council had taken 22.7m of the Pension prefunding to the General Fund.
- 32.1m of the 80m payment in 2021-22 financial statements had been accounted for directly to the General Fund. Whereas the remaining payment had been taken to Unusable Reserves.
- The Pension liability in the draft financial statements did not agree to the Pension liability by £57.3m due to managements interpretation of the accounting of this matter.

The above accounting treatment was not entirely consistent with managements papers setting out that they would account for the prefunding payment over 13 years to the General Fund. Therefore, initially we agreed with management that they should correct this, and this was done in the following adjustments:

As noted following our own internal quality review and a number of internal consultations on this key matter it was identified that the Council could not account for this impact over a 13-year period. This led to the following adjustment to the updated Statement of Accounts.

DR General Fund 100.6m

CR Unusable Reserves 100.6m

The above adjustments lead to the General Fund reducing by 46.2m at the 31st March 2022.

2. Financial Statements – Additional Areas of focus in 2021/22 – Other Risk Areas Continued

Issue	Commentary
Financial Instruments	During the 2021/22 financial year the Council has increased the long-term Loans provided to its subsidiaries. Our audit identified that these should be disclosed as part of the financial instruments note, as is required by IFRS9. This has led to a correction of £78.8m for 2021/22 and restatement of the prior year figures amounting to £33.2m within this note. See Appendix C.
Infrastructure Assets	Infrastructure assets contain a variety of assets including highway assets, drainage assets, pavements and lighting. The Code requires infrastructure to be reported in the Balance Sheet at depreciated historical cost, that is historic cost less accumulated depreciation and impairment. In addition, the Code requires a reconciliation of gross carrying amounts and accumulated depreciation and impairment from the beginning to the end of the reporting period. Westminster City Council had material infrastructure assets, at both a gross and net book value basis.
	There have been issues raised nationally about accounting for infrastructure assets which has delayed all audits across the sector. A Statutory Instrument was laid before Parliament in December 2022 to resolve these issues. The Code includes a temporary relief so that local authorities are not required to report the gross book value and accumulated depreciation for infrastructure assets from 2021/22 up to and including 2024/25.
	We have considered the reasonableness of the depreciation charge to infrastructure assets and obtained assurance that the useful economic lives applied to infrastructure assets is reasonable. We have also obtained assurance that the infrastructure asset disclosures in the financial statements are not materially misstated.
Leases	Leases are classed as finance leases where the terms of the agreement transfer substantially all the risks and rewards of ownership of the leased asset. Key factors considered include the length of the lease term in relation to the economic life of the asset, present value of the minimum lease payments in relation to the asset's fair value and whether the Council obtains ownership at the end of the lease term. All other leases are classified as operating leases.
	We have carried out testing of the treatment of leases. The accounting treatment and disclosures in the accounts comply with the requirements of IAS 8 par 31. The Council were able to produce the information required to satisfy completeness, but it was time consuming, and involved multiple audit supporting evidence. 3. Value for Money arrangements

Approach to Value for Money work for 2021/22

Improvement recommendation

3. VFM - our procedures and conclusions

As part of our work, we consider whether there are any risks of significant weakness in the Council's arrangements for securing economy, efficiency and effectiveness in its use of resources. We have not identified any risks.

Nothing has arisen through our VFM work that would impact on our planned audit opinion. Subject to the conclusion on the Council's internal review of procurement controls, for capital projects, under £0.1 million, referred to in the executive summary. This, as reported, will be covered in our combined Annual Auditors Report in February 2024 covering the 21-22 and 22-23 financial years.

Independent auditor's report to the members of Westminster City Council

Report on the Audit of the Financial Statements

Opinion on financial statements

We have audited the financial statements of Westminster City Council and its Group (the 'Authority') for the year ended 31 March 2022, which comprise, the Comprehensive Income and Expenditure Statement, the Movement in Reserves Statement, the Balance Sheet, the Cash Flow Statement, the Group Comprehensive Income and Expenditure Statement, the Group Movement in Reserves Statement, the Group Balance Sheet and the Group Cash Flow statement, the Housing Revenue Account (HRA) Statements, the Collection Fund Accounts and notes to the financial statements, including a summary of significant accounting policies. The financial reporting framework that has been applied in their preparation is applicable law and the CIPFA/LASAAC Code of practice on local authority accounting in the United Kingdom 2021/22.

In our opinion, the financial statements:

- give a true and fair view of the financial position of the Authority as at 31 March 2022 and of its expenditure and income for the year then ended;
- have been properly prepared in accordance with the CIPFA/LASAAC Code of practice on local authority accounting in the United Kingdom 2021/22; and
- have been prepared in accordance with the requirements of the Local Audit and Accountability Act 2014.

Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (UK) (ISAs (UK)) and applicable law, as required by the Code of Audit Practice (2020) ("the Code of Audit Practice") approved by the Comptroller and Auditor General. Our responsibilities under those standards are further described in the 'Auditor's responsibilities for the audit of the financial statements' section of our report. We are independent of the Authority in accordance with the ethical requirements that are relevant to our audit of the financial statements in the UK, including the FRC's Ethical Standard, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Conclusions relating to going concern

We are responsible for concluding on the appropriateness of the Executive Director of Finance and Resources' use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Authority's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify the auditor's opinion. Our conclusions are based on the audit evidence obtained up to the date of our report. However, future events or conditions may cause the Authority to cease to continue as a going concern.

In our evaluation of the Executive Director of Finance and Resources' conclusions, and in accordance with the expectation set out within the CIPFA/LASAAC Code of practice on local authority accounting in the United Kingdom 2021/22 that the Authority's financial statements shall be prepared on a going concern basis, we considered the inherent risks associated with the continuation of services provided by the Authority. In doing so we had regard to the guidance provided in Practice Note 10 Audit of financial statements and regularity of public sector bodies in the United Kingdom (Revised 2020) on the application of ISA (UK) 570 Going Concern to public sector entities. We assessed the reasonableness of the basis of preparation used by the Authority and the Authority's disclosures over the going concern period.

Based on the work we have performed, we have not identified any material uncertainties relating to events or conditions that, individually or collectively, may cast significant doubt on the Authority's ability to continue as a going concern for a period of at least twelve months from when the financial statements are authorised for issue.

In auditing the financial statements, we have concluded that the Executive Director of Finance and Resources use of the going concern basis of accounting in the preparation of the financial statements is appropriate.

The responsibilities of the Executive Director of Finance and Resources with respect to going concern are described in the 'Responsibilities of the Authority, the Executive Director of Finance and Resources and Those Charged with Governance for the financial statements' section of this report.

Other information

The Executive Director of Finance and Resources is responsible for the other information. The other information comprises the information included in the Statement of Accounts, other than the financial statements, our auditor's report thereon, and our auditor's report on the pension fund financial statements. Our opinion on the financial statements does not cover the other information and, except to the extent otherwise explicitly stated in our report, we do not express any form of assurance conclusion thereon.

In connection with our audit of the financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial statements, or our knowledge obtained in the audit or otherwise appears to be materially misstated. If we identify such material inconsistencies or apparent material misstatements, we are required to determine whether there is a material misstatement in the financial statements or a material misstatement of the other information. If, based on the work we have performed, we conclude that there is a material misstatement of the other information, we are required to report that fact. We have nothing to report in this regard.

Other information we are required to report on by exception under the Code of Audit Practice

Under the Code of Audit Practice published by the National Audit Office in April 2020 on behalf of the Comptroller and Auditor General (the Code of Audit Practice) we are required to consider whether the Annual Governance Statement does not comply with 'delivering good governance in Local Government Framework 2016 Edition' published by CIPFA and SOLACE or is misleading or inconsistent with the information of which we are aware from our audit. Explanation as to what extent the audit was considered capable of detecting irregularities, including fraud

Owing to the inherent limitations of an audit, there is an unavoidable risk that material misstatements in the financial statements may not be detected, even though the audit is properly planned and performed in accordance with the ISAs (UK).

The extent to which our procedures are capable of detecting irregularities, including fraud is detailed below:

- We obtained an understanding of the legal and regulatory frameworks that are applicable to the group and Authority and determined that the most significant ,which are directly relevant to specific assertions in the financial statements, are those related to the reporting frameworks (international accounting standards as interpreted and adapted by the CIPFA/LASAAC Code of practice on local authority accounting in the United Kingdom 2021/22, the Local Government Act 1972,the Local Government and Housing Act 1989, the Local Government Finance Act 1988 (as amended by the Local Government Finance Act 1992), the Local Government Finance Act 2012, the Local Audit and Accountability Act 2014, the Accounts and Audit Regulations 2015 and the Local Government Act 2003.
- We enquired of senior officers and the Audit Panel, concerning the group and Authority's policies and procedures relating to:
 - the identification, evaluation and compliance with laws and regulations;
 - the detection and response to the risks of fraud; and
 - the establishment of internal controls to mitigate risks related to fraud or non-compliance with laws and regulations.
- We enquired of senior officers, internal audit and the Audit Panel, whether they were aware of any instances of non-compliance with laws and regulations or whether they had any knowledge of actual, suspected or alleged fraud.
- We assessed the susceptibility of the Authority and group's financial statements to material misstatement, including how fraud might occur, by evaluating officers' incentives and opportunities for manipulation of the financial statements. This included the evaluation of the risk of management override of controls. We determined that the principal risks were in relation to:
 - journal entries posted which met a range of criteria determined during the course of the audit, in particular those posted around the reporting date which had an impact on the Comprehensive Income and Expenditure Statement, and
 - accounting estimates made in respect of the valuation of assets and liabilities in the Balance Sheet

- Our audit procedures involved:
 - evaluation of the design effectiveness of controls that the Executive Director – Finance and Resources has in place to prevent and detect fraud;
 - journal entry testing, with a focus on entries meeting the risk criteria determined by the audit team;
 - challenging assumptions and judgements made by management in its significant accounting estimates in respect of valuation of land and buildings including council dwellings, and the valuation of the defined benefit pensions asset valuations;
 - assessing the extent of compliance with the relevant laws and regulations as part of our procedures on the related financial statement item
- These audit procedures were designed to provide reasonable assurance that the financial statements were free from fraud or error. The risk of not detecting a material misstatement due to fraud is higher than the risk of not detecting one resulting from error and detecting irregularities that result from fraud is inherently more difficult than detecting those that result from error, as fraud may involve collusion, deliberate concealment, forgery or intentional misrepresentations. Also, the further removed non-compliance with laws and regulations is from events and transactions reflected in the financial statements, the less likely we would become aware of it.
- The team communications in respect of potential non-compliance with relevant laws and regulations, including the potential for fraud in revenue and expenditure recognition, and the significant accounting estimates related to valuation of land and buildings, including council dwellings and investment property, and the valuation of the net defined pensions asset.
- Our assessment of the appropriateness of the collective competence and capabilities of the group and Authority's engagement team included consideration of the engagement team's.
 - understanding of, and practical experience with audit engagements of a similar nature and complexity through appropriate training and participation
 - knowledge of the local government sector
 - understanding of the legal and regulatory requirements specific to the Authority and group including:
 - the provisions of the applicable legislation
 - guidance issued by CIPFA, LASAAČ and SOLACE
 - the applicable statutory provisions.

- In assessing the potential risks of material misstatement, we obtained an understanding of:
 - the Authority and group's operations, including the nature of its income and expenditure and its services and of its objectives and strategies to understand the classes of transactions, account balances, expected financial statement disclosures and business risks that may result in risks of material misstatement.
 - The Authority and group's control environment, including the policies and procedures implemented by the Authority and group to ensure compliance with the requirements of the financial reporting framework.

Report on other legal and regulatory requirements – the Authority's arrangements for securing economy, efficiency and effectiveness in its use of resources

Matter on which we are required to report by exception – the Authority's arrangements for securing economy, efficiency and effectiveness in its use of resources

Responsibilities of the Authority

The Authority is responsible for putting in place proper arrangements for securing economy, efficiency and effectiveness in its use of resources, to ensure proper stewardship and governance, and to review regularly the adequacy and effectiveness of these arrangements.

Auditor's responsibilities for the review of the Authority's arrangements for securing economy, efficiency and effectiveness in its use of resources

We are required under Section 20(1)(c) of the Local Audit and Accountability Act 2014 to be satisfied that the Authority has made proper arrangements for securing economy, efficiency and effectiveness in its use of resources. We are not required to consider, nor have we considered, whether all aspects of the Authority's arrangements for securing economy, efficiency and effectiveness in its use of resources are operating effectively.

We have undertaken our review in accordance with the Code of Audit Practice, having regard to the guidance issued by the Comptroller and Auditor General in December 2021. This guidance sets out the arrangements that fall within the scope of 'proper arrangements. When reporting on these arrangements, the Code of Audit Practice requires auditors to structure their commentary on arrangements under three specified reporting criteria:

This representation letter is provided in connection with the audit of the financial statements of Westminster City Council for the year ended 31 March 2022 for the purpose of expressing an opinion as to whether the group and Council financial statements are presented fairly, in all material respects in accordance with International Financial Reporting Standards and the CIPFA/LASAAC Code of Practice on Local Authority Accounting in the United Kingdom 2021/22 and applicable law.

We confirm that to the best of our knowledge and belief having made such inquiries as we considered necessary for the purpose of appropriately informing ourselves:

Financial Statements

- i. We have fulfilled our responsibilities for the preparation of the group and Council's financial statements in accordance with International Financial Reporting Standards and the CIPFA/LASAAC Code of Practice on Local Authority Accounting in the United Kingdom 2021/22 ("the Code"); in particular the financial statements are fairly presented in accordance therewith.
