ELECTION OF A MEMBER OF PARLIAMENT
CITIES OF LONDON AND WESTMINSTER CONSTITUENCY**

1. ELECTION

An Election is to be held for a Member of Parliament for the above Constituency.

2. REGISTERING TO VOTE.

The deadline for receiving applications for registration - not later than **midnight** on **TUESDAY 26 NOVEMBER 2019**.

3. NOMINATION PAPERS

Nomination Papers may be obtained from the offices of the Acting Returning Officer, Electoral Services, 14th Floor, Westminster City Hall, 64 Victoria Street, London, SW1E 6QP, on Monday to Friday, between the hours of 10am and 4pm, who will at the request of any elector for the constituency prepare a nomination paper for signature.

4. DELIVERY OF THE NOMINATION PAPERS

Nomination Papers must be delivered to the Acting Returning Officer, Electoral Services, 14th Floor, Westminster City Hall, 64 Victoria Street, London, SW1E 6QP, on any day after the date of this notice, on Monday to Friday between the hours of 10am and 4pm, but not later than **4pm on THURSDAY, 14 NOVEMBER 2019**. The £500 deposit can be paid by cash (British pounds only) or by means of a banker's draft, made payable to City of Westminster, from a drawer which carries on business as a banker in the United Kingdom.

5. POLL

If the poll is contested, a poll will take place on **THURSDAY 12 DECEMBER 2019**.

The hours of poll will be 7am to 10pm.

6. ABSENT VOTES

New applications to vote by post, or to change or cancel an existing postal, proxy or postal proxy vote must reach the Electoral Registration Officer not later than **5pm on TUESDAY, 26 NOVEMBER 2019**.

New applications to vote by proxy (except postal proxies or emergency proxies) must reach the Electoral Registration Officer not later than **5pm on WEDNESDAY, 4 DECEMBER 2019**.

Emergency proxy applications on the grounds of physical incapacity or for work /service reasons must reach the Electoral Registration Officer not later than **5pm on THURSDAY, 12 DECEMBER 2019**.

All applications and notices regarding absent voting for electors in the Westminster City Council area must be sent to the Electoral Registration Officer, Electoral Services, 14th floor, Westminster City Hall, 64 Victoria Street, London, SW1E 6QP.

All applications and notices regarding absent voting for electors in the City of London area must be sent to the Electoral Registration Officer, Electoral Services, Town Clerk's Dept, Guildhall, PO Box 270, London, EC2P 2EJ.
